I understand that Hidden Lake is a clothes-free nudist club and agree that at all times while on the Club's grounds it is required that I, and everyone in my party will be nude, except for the specific times when clothing may be worn that are listed in the Club's Guidelines.

I understand that the privacy is very important and the information I have submitted will be held in strict confidence and that it will only be used by the Club for administrative purposes and may be used to conduct background checks that I hereby agree to and consent to. I understand that photography or video recording is not permitted, and cell phones shall be used in such a way that others do not believe I am violating this rule. I shall not share names or identifying information about other members or visitors with non-members outside of the Club.

I agree that any losses or injuries of any nature whatsoever, sustained by me, or by any of my guests or visitors, either on the grounds of Hidden Lake Resort, as a result of my visit and membership to Hidden Lake Resort, or background checks therein shall not be held as Club liabilities. I agree to hold harmless and wholly non-liable Hidden Lake Resort and any of its Managers, staff, members or its assets. I agree to practice safety at all times and in all of my activities and to assume full responsibility for the safety and welfare of myself, my guests and visitors. All members of my party, visitors, guests and I will use the grounds and facilities at our own risk and thereby release the Club, staff and Club members from any and all liability.
